FROM SHORT, URBAN RIDES TO MULTI-DAY TOURS, THE CLUB OFFERS WORLD-CLASS EVENTS, TRAINING SERIES, AND SOCIAL GROUP RIDES. SERVING OVER 30,000 PEOPLE ANNUALLY, THE CLUB'S FLAGSHIP EVENT IS THE SEATTLE TO PORTLAND RIDE, WHERE 10,000 PEOPLE MAKE THE 200 MILE TRIP BY BICYCLE IN ONE OR TWO DAYS. ALSO, WE HAVE RECEIVED \$29,645 PROMOS RUN ON A LOCAL RADIO TO ADVERTISE OUR EVENTS TO ATTRACT MORE PEOPLE TO GET INVOLVED.
