



## Permission to Walk/Ride Home

Dear Parent or Guardian,

If you want to allow your child (of 11 years of age or older) to walk or ride their bicycle unaccompanied home from our Summer Camp programming, please fill out the form below and return it to Camp Administrative staff via email, mail, or on the first day of programming. Your child will not be allowed to leave the designated camp headquarters unaccompanied until this form has been received by the camp administrators. **THIS FORM ONLY APPLIES TO THOSE CAMPER WHO WILL WALK OR RIDE HOME UNACCOMPANIED.** Camp Administration should already have on file the person(s) designated to pick up your child (filled out within the Camp Medical Form).

**I am aware that once my child leaves the camp headquarters there is no supervision for them and that Cascade Bicycle Club has no further responsibility or liability for injuries or events that occur thereafter.** I have made my child aware that for their safety they are **not** allowed to loiter around the premises after camp or at any nearby business, and they are to go directly to their after camp destination.
